

- 6) Addition of modules on interview preparation, and resume writing to boost employability.



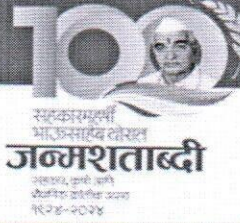
